

CYO BASKETBALL REFEREE TRAINING QUIZ

POSSESSION ARROW

Which direction does the arrow point -- to the team's basket or the team's bench?

TIME-OUTS

How many time-outs does a team get each half?

How many thirty second time-outs does each team get in grade school CYO basketball?

How many thirty second time-outs does each team get in high school CYO basketball?

JUMP BALL

On a jump ball when does the clock start?

How many times can a jumper legally tap the ball?

Can a jumper get the ball once it hits the floor?

THROW-IN

On a throw-in, how long does the thrower have to get the ball in bounds?

Can a thrower call a time-out once the referee has given him/her the ball and began the count?

Can the defensive team call a time-out once the thrower has been given the ball for a throw-in?

When does the throw-in count end?

When does the clock start on a throw-in (if the clock is off)?

BEGINNING OF OVERTIME

The game is going into overtime. The arrow is pointing to team A's basket. Who gets the ball to begin the overtime session?

What happens to the arrow after you begin the overtime period?

BONUS FREE THROW

How many team fouls committed by an opponent are needed before a team is allowed to shoot one & one?

How many team fouls committed by an opponent are needed before a team is allowed to shoot the double bonus (two shots)?

Does a technical foul on a player count toward the team total?

Does a technical foul on a player count toward the player's foul total?

Does a technical foul on a coach count toward the team foul total?

FREE THROW LANE

On a free throw, how many players are allowed to stand on each side of the lane?

When are the players in marked lane spaces allowed to enter the lane on a free throw?

When is the shooter on a free throw allowed to enter the lane?

What happens if the non-shooting team commits a violation before the shooter has the ball?

What happens if the non-shooting team commits a violation after the shooter has the ball?

What happens if the shooting team commits a violation prior to the ball being shot?

What happens if both teams commit a violation during the same try?

What happens if the attempted free throw hits only the backboard?

THREE SECONDS IN THE KEY

How many players on the court may be called for three seconds in the key while the ball is in team A's possession in team A's frontcourt?

When does a new count begin for three seconds in the key?

Does a new count begin if a shot is attempted?

Does a new count begin if a shot is attempted but does not hit anything (rim, backboard,...)?

OVER & BACK

If an offensive player is in the backcourt with the ball and crosses the time-line with one foot and the ball (one foot is still in the backcourt), and while continuing to dribble goes back into the backcourt. Is this legal?

PLAYER CONTROL FOUL

What is a player control foul?

How many free throws are awarded on a player control foul?

CYO TIMING RULES (metro Toledo leagues)

How long are CYO grade school quarters?

When does the clock start during CYO grade school quarters?

How long is a 5th grade overtime?

How long is an 8th grade overtime?
